



Tent Permitting

General permitting requirements:

- Tents less than 800 sqft that are not used for cooking, fireworks, or storage or sale of combustible material do not require a permit.
- Tents over 800 sqft DO require a permit. Provided the requirements below are met, AAE is prepared to assist in the permitting process.
- Tents to be used for cooking, fireworks, or storage or sale of combustible material DO require a permit. As luck would have it, AAE does not participate in these permits.

Client requirements:

Fees:

- \$599 – Permit with all necessary documents listed below submitted more than 30 days in advance of installation and without electric, (e.g., lighting, fans, etc.)
- \$799 – Permit with necessary documents listed below submitted less than 30 but more than 14 days in advance of installation and without electric, (e.g., lighting, fans, etc.)
- Any permits with electric, add \$100 to above pricing

Information to be provided to AAE:

- Detailed site plan (See example attached.)
- Property owner's written authorization for AAE to act on their behalf, i.e. complete permit application, etc. (See example attached. Must be signed by property owner and notarized.)
- Affidavit for electrical work signed by property owner. (Attached. Must be signed by property owner and notarized.)

Time required: A 72 hour window is required from set-up to event time to allow for required inspections.

****NOTE: AAE cannot guarantee permitting unless all information and time requirements listed above are met completely. All permit fees are non-refundable.**

All About Events to provide:

- Completion of permit application, including notarization
- Detailed drawings of tent and contents
- Certificate of flame resistance
- Permit expediting, including building, zoning, development services, and fire department approvals
- Scheduling of all inspections
